## RISK ACKNOWLEDGEMENT & WAIVER

Victorian Agricultural Shows Ltd and Bunyip Agricultural Show Society (together “the Suppliers”) advise that participation in animal handling at an agricultural show contains elements of risk, both obvious and inherent. The handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

By signing this waiver, I acknowledged that:

- Participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me;
- Participation in animal handling requires certain skills. I declare that I have sufficient skills to be able to safely and properly participate in the events;
- Animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;
- Animal showing events will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises which can frighten animals;
- If the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;
- Insects or other animals may cause animals to become frightened and act in an unpredictable way;
- There is inherent in events involving the handling of animals the risk of suffering injury including injuries caused by animals; and
- I use the facilities of Bunyip entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.
- If I suffer harm while participating in an animal-handling event, I will not hold the Suppliers, their employees or agents legally responsible for any injuries I suffer. I will not sue the Suppliers, their employees or agents for any claims, costs, damages or liability. I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided.
- I acknowledge and agree that my participation in the event and associated activities is a danger and may have inherent risks as a result of which personal injury (and sometimes death) may occur and I accept and assume all such risks of personal injury or death in anyway whatsoever arising from these activities and hereby waive my individual right to sue the Suppliers for all claims I or my representatives may have for such personal injury or death against the Suppliers in any way whatsoever arising from or in connection with these activities.
- I will not consume any alcohol or illicit drugs while participating in the event and agree that such use may result in me being excluded from an event with no entitlement to any refund of money paid for entry to the Suppliers.
- I agree to be bound by the rules and guidelines of Victorian Agricultural Shows Ltd as varied from time to time.

#### WARNING UNDER THE FAIR-TRADING ACT 1999
